

Minutes
Levan Town Council Meeting
February 13, 2019
7:00 P.M.

1. Opening ceremonies:

The meeting was called to order at 7:03 PM by Mayor Corey Christensen. The invocation was offered by Councilmember Ray Evans. The Pledge of Allegiance was led by Mayor Corey Christensen.

Town Officials present: Mayor Corey Christensen and Councilmembers Ray Evans, Bruce Rowley, and Brett Hone. Councilmember Clifford Christensen was unable to attend.

2. Discussion Items:

- a. John Bradley from Nephi Recreation came and gave an update on recreation programs and participation. Levan Town had 211 participants in programs that required registration. Nephi Recreation provides programs for residents of all ages in Juab County including Youth Sports, Adult Sports, Swimming Pool, Enrichment Classes, Ballfield & Gymnasium Access, and Special Events. He had copies of the Nephi Recreation Brochure available. Mr. Bradley offered to help with equipment for a Movie in the Park event in Levan.
