If at any time your account is not in good standing, Levan Town has the right to discontinue your service (Ordinance 7.02.040).

If at any time your service is disconnected for nonpayment, a \$50.00 disconnect and \$50.00 reconnect fee will be charged. If a worker is sent out to disconnect your utilities and the bill is paid in full at that time, a \$50.00 disconnect fee will still apply. If the utilities are disconnected for non-payment, the account must be brought current and all fees paid before the utilities will be reconnected. (Resolution 10102018-01).

In the event any balance is not paid as agreed, the undersigned agrees to pay a collection fee not to exceed 40% of the unpaid balance. In the event a lawsuit is brought against you to collect the unpaid balance, the undersigned further agrees to pay court costs and reasonable attorney fees in addition to the collection fee. The undersigned further authorizes us or our agent to call you at any number you provide or at any number at which we or our agent reasonably believes we can contact you, including calls to mobile, cellular, or similar devices for any lawful purpose. The undersigned also agrees to any fee(s) or charge(s) that may be incurred for incoming calls from us or our agent, and/or outgoing calls to us or our agent, to or from any such number, without reimbursement.
